# How to proceed with your application

## STEP 1

Complete and sign the tenancy application form and return it to the Northwood office below along with your Reservation / Admin fee, preferably in cash as your application can then be processed immediately. Please also provide photographic identification of who you are (i.e. passport or new style driving license) and two utility bills detailing your current address.

#### STEP 2

Assuming your application has been accepted, you will need to pay the Balance Due either in cash, bankers draft or building society cheque when you move into the property or if you wish to pay be a personal cheque then you must pay it at least one week before you are due to move into the property. Please make all cheques payable to Northwood. **Deposit may vary depending on your credit history and personal circumstances**.

## Declaration

I understand that providing false information may lead to a tenancy being refused or early termination of any subsequent tenancy agreement.

Northwood may use a third party referencing agent, if so you agree to being contacted by that agency, Northwood will make you aware of that company if used.

Northwood or their selected third party referencing agents will hold your data securely and only use it with regard to the referencing for this tenancy application and future tenancy.

As a condition of the tenancy you will be required to have Tenant Liability Insurance throughout the term of your tenancy. You understand that Northwood will pass your details for a 'no obligation' quote, and if you do not wish to take advantage of the quote given then proof of a suitable policy must be shown prior to the commencement of the tenancy.
